Refer:- Your Letter No-20-23/2016-SPB-II Dated 24-01-2018.

Vide your above referred letter regarding security arrangements in Udhampur HO, a copy of letter No. FNPO/J&K/security/Udhampur HO/2017 dated 12-12-2017 from (Sh T.N.Rahate General Secretary and President FNPO, National Union of Postal employees) has also been enclosed along with issues raised by him in the Memorandum.

I am directed to intimate the status of the Security arrangements in Udhampur HO and status of the issues raised by the General Secretary as under:-

A) <u>Security Arrangements in Udhampur HO</u>

1 Theft at Udhampur head Post office took place in May-2009; thereafter no untoward incident has happened in the Udhampur head post office complex.

2. Outsourced security arrangement has been provided at Udhampur HO by tenders on regular basis. The tenders expired on 31-10-2017. SPOs Udhampur sent tender for approval to Circle office. In the meantime GST was introduced and tender was returned to SPOs Udhampur for including aspects of GST. Revised draft tender has been received from SPOs Udhampur and same has been approved. The tender has also been uploaded on web site.

B) <u>Status of other issues raised by the General Secretary.</u>

Status of other issues raised by the General Secretary is enclosed in Annexure-A, for your information please.

C. It is also submitted that issues raised by the General Secretary are local issues related to Circle level and Divisional level which can be resolved by the direct interaction of Circle Secretary with HOC and Divisional Secretary with divisional Heads. It is requested that General Secretary may kindly be advised to direct his circle Secretaries to take up the issues at Circle level/Divisional level.

In this connection I am directed to intimate that Post of GDS BPM Kotli Mian Feteh BO was notified by the SSPOs Jammu vide Memo No ED-641/GNR dated 11-03-2016. The said Sh. Roshan Lal having highest merit in 10th class was asked to produce prescribed OBC/category certificate in Annexure-III and other testimonials. These documents were forwarded to concerned authority for verification of their genuineness.

Meanwhile Postal Directorate vide letter No. 17-23/2016-GDS dated 01-08-2016 conveyed that all the selection/engagement of all types of GDS (s) may be stopped. It was also been conveyed that cases where selection has already been finalized & communicated to the candidate's only need not to be withheld.

In the instant case though the requisite documents were called from the candidate concerned and verification process completed, but the candidate concerned was never specifically informed about his selection against the Post of GDS BPM Kotli Mian Feteh BO. As such the notification issued for engagement of GDS BPM Kotli Mian Feteh BO was cancelled by SSPOs Jammu vide letter No. ED-641/GNR dated 25-10-2017.

Dear commrades,

May this letter reach to you in sound health. Needless to say about the inordinate delay in implementing the GDS committee recommendations.

The pay and other allowances of about 42 Lakhs Central Government employees in different Departments and the pension of an equal number of pensioners have been revised with effect from 01.01.2016 as per the recommendations of the 7th CPC submitted to the government with in 8 months. But the allowances of 243717 GDS employees have not been revised even though 16 months have elapsed after submission of Shri. Kamlesh Chandra committee report. Whenever the matter is discussed with concerned authorities no categorical reply about implementation is not given. We know that 92% of the departments operative works are done by the GDS employees who work in the rural sector. But the authorities are dilly dallying when the genuine demands of the GDS employees are brought to their notice.

We have been resorting to various agitational programmes throughout the country for implementing the GDS Committee recommendations. But the concerned authorities are not considering favorably the genuine and long awaited pay revision. All the unions in this field

have met personally the MPs Ministers and apprised of them the urgent need of action on the part of Government of India. We have also brought the matter to the notice of Finance Minister and Honourable Prime Minister. They have not interfered in the matter for early settlement.

Another serious problem affecting the GDS employees is that as per the rule they have to work maximum five hours only. But almost all employees have to work more than the prescribed hours. BPM, GDS MDs, GDS Packer have to work for 6 hours to 10 hours. This fact was revealed in the statistics of the Department. The stand of the Department is that no GDS employees has to work more than the prescribed hours ie; 5 hours or he does not have to work beyond hours. GDS employees are forced to work more than their duty hours as slaves. The employees who deny to do excess work are threatened by Rule 3 A(1) of GDS Conduct and Engagement rules. Besides in many circles Sub Divisional Inspectors/Divisional Supdts are torturing the GDS employees in the name of fall in business. The employees are compelled to open SB/RD accounts pay RPLI premia taking money from their pockets. The target is fixes not according to the population of their villages. Therefore they cannot attain the target which results in mental torture. They are even threatened removal from service and publishing the news in dailies.

We can no longer tolerate this type of attitude. We have to organise agitation programmes under a joint platform to address the grievances of the GDS employees. It is sure that there can be no two opinion among the various GDS unions in addressing the grievances of the employees, even if there may be slight difference in ideology.

The attitude of NUGDS is that immediate agitation programmes are to be resorted to settle our primary demands. (1) Implementation of GDS committee report and removal of Rule 3 A (1) of GDS CE Rule. If the authorities do not pay heed to our demand we may have to resort to direct action including stoppage of work closing down the office. But systematic steps are required to make the employees aware of the present situation. As a first step I suggest that a joint meeting of AIGDSU, AIGDSU (NFPE), BPEDEU and NUGDS may be convened at a convenient place preferably Bangalore/Hyderabad/New Delhi to discuss about the steps to be taken. The All India Presidents and General Secretaries of the unions may participate in the proposed meeting. We can put the Department and Central Government under pressure only if we resort to direct action. The whole hearted support of general public will be extended to us.

I request you to take a positive actions in this regard.
