Filling up vacant post of Postman and MTS

Last year on 8th November, 2016 our Prime Minister announced the cancellation of currency notes of Rs. 1000/- and Rs. 500/- and declared those notes as piece of paper.

On this announcement the public was shocked throughout the Country. From 9th November, 2016 the long queues were formed in front of Banks authorised for change of currency notes by the people before opening of Bank counters.

The main reason for this cancellation of currency notes were given by the Government was that -

(1) To recover the black money; (2) To cancel
the fake notes; (3) To stop the financial aid to naxalites
and anti-national group; (4) To make digital India
by using credit card, mobile apps etc.

If we study the result of this notebandi; we found that the reasons given by notebandi are totally failed.

(1) The total 98.96% currency notes are exchanged in Banks, it means only 1.5% currency notes are lying unaccounted for; so what about black money.

(2) On 8th November, 2016 according to source less than 2% fake notes were in currency and only for such a small portion of currency the cancellation of all currency notes of Rs. 1000/- and Rs. 500/was not a proper decision.

(4) To make digital India this notebandi has not been fruitful as we are not able to use credit cards and mobile apps on the other hand after compulsory use of credit cards the loss of 60 thousand crores of rupees as debit.

From all these reasons the decision of notebandi proved a failure.

8 नवंबर, 2016 नोटबंदी की पहली वर्षगांठ

पिछले वर्ष 8 नवंबर, 2016 की रात हमारे आदरणीय प्रधानमंत्रीजी ने दूरदर्शन पर घोषित किया कि आज और अभी से 500/- और 1000/- के नोट रद्द किये गये हैं और वे नोट अब महज कागज के ट्कड़े हो गये हैं।

इस घोषणा के साथ ही सारे देश में हड़कंप मच गया और दूसरे दिन से बैंक और कुछ पोस्ट ऑफिस के सामने लंबी कतार में नोट बदली के लिए लोग खड़े हो गये।

एक पूरे वर्ष बाद इस नोटबंदी के निर्णय की आज सभी स्तर पर समीक्षा की जा रही है। नोटबंदी के लिए नीचे लिखे चार कारण बताये गये थे -

(1) अर्थ व्यवस्था में छुपा काला धन समाप्त करना; (2) नकली नोट समाप्त करना; (3) अतिरेकी संगठनों को मिलनेवाली अर्थ सहायता समाप्त करना; (3) अर्थ व्यवस्था को नगदी रहित कर मशीनीकरण द्वारा अर्थ व्यवहार करना। इन चारों कारणों का एकत्रित विचार करे तो साफ होता है कि रदद किये गये नोट 98.96% के प्रमाण में फिर

से बैंकों में वापस बदल कर आ गये हैं। इसका अर्थ है कि 1.15% भी कालाधन रद्द नहीं हुआ है।

जब यह निर्णय नोटबंदी का लिया गया उस वक्त नकली नोट 2% से भी कम के प्रमाण में था यदि यह माना जाये कि यह निर्णय इसीलिए लिया गया तो यह कुछ ठीक नहीं प्रतीत होता, जैसे घर के किसी कोने में यदि मच्छर है तो घर को ही जला दिया जाये।

8 नवंबर 2016 के बाद जम्मू कश्मीर में आज तक जो अतिरेकी हमले हुए इससे साबित हो गया कि अतिरेकी संगठनों को मिलने वाली आर्थिक सहायता में नोटबंदी के कारण कोई कमी नहीं आयी है।

अर्थ व्यवस्था में नगदी का प्रचलन कम कर मशीनों द्वारा जैसे क्रेडिट कार्ड, मोबाईल एप्स का उपयोग कर क्रय विक्रय को चला देने का उद्देश्य भी सफल नहीं हुआ है और सरकार द्वारा क्रडिट कार्ड की सक्ति का परिणाम - एक साल में 60 हजार कोटी रुपये डूब गये हैं।

इस सारी प्रक्रिया में सामान्य नागरिक कठिनाइयों से लड़ रहा है। नोटबंदी से देशभर में करोड़ों लोगों का रोजगार छीन गया है। रोजमर्रा के काम करनेवाले परेशान हैं।

रिजर्व बैंक का वार्षिक लेखा-जोखा वर्ष 2016-17 के अनुसार रद्द किये गये 15.44 लाख कोटी रुपयों के बदले 15.28 लाख कोटी रुपयों के नोट 30 जून 2017 को बैंक में जमा किये गये हैं। इस का अर्थ यह है कि रिजर्व बैंक के अनुसार केवल एक फीसदी 1.1% रद्द किये गये नोट बदले नहीं गये हैं।

इस लेख का उद्देश्य सिर्फ जो हुआ है और जो होने जा रहा है उस पर प्रकाश डालना है।

Respected Sir,

In connection of above cited subject it is to bring to your kind notice that the staff of Andal MDG and Kajoragram are deprived of their legitimate right of 20% HRA as per the Rules on the subject. The **Railway employees** of the said area are getting HRA at 20% since May 2005.

Sir, according to the available records the last Order No. 4-9/96-PAP dated 8-8-2004 from the Department in respect of 20% HRA to Andal MDG and Kajoragram was issued. Due to that Order till April 2005 the said staff received their 20% HRA accordingly. But since May 2005 till 30-4-2017 we feel due to non-availability of Dependency Certificate from District Magistrate, Burdwan, which were not obtained by the competent Authority of Department of Posts the staff is deprived for 20% HRA.

Sir, it is pitiable condition that though the issue is taken at Division, Regional and **Circle level** no any cognizance was taken by the competent Authorities to solve the problem which is not yet the problem. The **other Central Government Departmental**

Employees were getting the HRA at the rate of 20% while their **Authorities obtained Dependency Certificates from the District Magistrate, Burdwan time to time,** hence the said issue did not arise in their Department. Here already the staff Union has taken the issue which was not handled properly and closed without any final action by Administration level.

Sir, in this regards it is learnt that the SPM Andal, Kajoragram and the SSPOs, Asansol Division, Asansol-713301 has already submitted the Dependency Certificate from year May 2005 to 30-4-2008.

The said copies of SPM Andal MDG-713321, Kajoragram and the SSPOs, Asansol Division, Asansol-713301 alongwith photo copies of Dependency Certificates are enclosed for your Office ready reference please.

Sir, Andal MDG and Kajoragram are the non-municipal urban area within the periphery of 8 km from Durgapur Municipal Corporation. Following points may be observed in the case and suitable instructions would be issued to the concerned to sanction the 20% HRA without lapse of further time or if the same case is not in the power of the CPMG, West Bengal Circle then the Directorate may take immediate action by obtaining the required 'Dependency Certificates' of concerned years/period from the Circle Office and do the needful.

- (i) As per the correspondence the dependency certificate from May 2005
 to April 2008 is obtained and submitted to Circle Office by concerned.
- (ii) The period is renewed after each three years hence the 'dependency certificate' for 1-5-2008 to 30-4-2011, 1-5-2011 to 30-4-2014 and 1-5-2014 to 30-4-2017 should be obtained from the District Magistrate Burdwan. If the said is not obtained the concerned Authority must direct to obtain the same and to be submitted to the Circle immediately.
- (iii) Same is the case of another period of **1-5-2017 to 30-4-2020.**

In connection of the above cited subject kindly refer my Union Letter of Even No. dated 22-7-2015 and 15-12-2016 wherein all details for the subject were discussed. But till date nothing is heard on the issue.

According to this Order the Time Factor allowed to Postmen for delivery of article is walk distance calculated for main road, lanes and by-lanes. But distance is not calculated for entering various houses and inside area of buildings and multi storey buildings while measuring the beat of Postman this distance is also not taken into account.

There is no increase in **Time Factor for unregistered articles**, instead Time Factor has been **reduced** for delivery of unregistered articles.

Order DG P&T No. 31-38/79-PE-I dated 22-5-1979 = distance travelled means distance covered on the main road; **lanes and by-lanes.** Distance covered for entering various houses and multi-storey buildings is **included** in the time factor for delivery of articles (DG P&T No. 31-38/79-PE-I dated 22-5-1979.

The above Orders of dated 22-05-1979 may be modified as -

Distance travelled means distance covered on the main road; lanes and by-lanes for entering various houses, buildings and multi-storied buildings inside area and door-to-door (Article delivery point) should be measured in time factor as footwalk **excluding** time factor of delivery of articles.

Sir, Time Factor for unaccountable Article was 0.75, but in Revised Norms 2010 it was reduced to 0.72.

For Accountable Articles delivery in multistorey buildings 1.80 Time Factor has been given additionally.

But Unaccountable (Ordinary) Articles are to be delivered door to door in multistorey buildings, but no additional Time Factor is given.

Therefore Union demands that Orders dated 22-5-1979 should be changed or Additional Time Factor should be given for door to door delivery of Unaccountable Article. (Unaccountable (Ordinary) Articles means ordinary mail).

There is vast change from **1979 to 2017** regarding construction of multistoried buildings and malls. **India is now on the verge of touching the sky.** Union request that necessary modification may be Ordered while measuring the Postman Beat. The walk should be **calculated actually to the door step** of address or upto Post Boxes installed in premises of the building, ample correspondence has already been made in this regard.

Sir, in this connection one meeting was also taken place and we were assured that the Orders would be issued shortly. But we are still awaiting.

Sir, as per Letter Dated **22-5-1979** the multistoreyed building would provide the Letter Boxes at Ground Floor for each residents separately. Although the **Scheme** was of 38 years old merely 2% to 5% residents have given response for the same. However, the Postman had to reach upto the **Letter Box fixed** in the said premises. Hence, the distance upto that point must be counted and **door to door physical distance** would be mapped from the Post Office of the said beat.

So a separate clear Order in full is necessary to be issued after discussion.

Therefore, it is sincerely requested to fix a meeting with both the Unions to discuss the issue and finalize the issue. Please intimate the date and time of the meeting and also arrange for my relief to attend the meeting. The letter of meeting may be posted and also on my e-mail address.

In connection of above cited subject it is to bring to your kind notice that while on tour to West Bengal Circle it is observed that the **Part Time Casual Labours** (Contigency Staff) are deprived from their due arrears of **1-1-2006** and from **1-1-2016**. The Local and Circle Union Office Bearer pointed out that the wage revision of the **Part Time Casual Labours** are also not done in West Bengal Circle.

Sir, in this respect the Directorate had already issued the Clarification and Orders vide 22nd January, 2015 and subsequent Clarification on 17-6-2016 and 31-3-2017. But

nothing is done in this Circle yet. Hence, you are kindly requested to issue necessary instructions to the **Chief Postmaster General** in Bengal Circle to effect the Order without passing further time.

Therefore Union request that as per the **6th CPC and 7th CPC pay fixation should be given immediately** to this poor Contingency Staff (Part Time Casual Labour).

And secondly, Orders should be issued to CPMG, West Bengal to please give

6th CPC pay fixation arrears from 1-1-2006 and 7th CPC pay fixation arrears from 1-1-2016 immediately.

A line of action is awaited from your kind Honour.
