Details of visits to Dak Bhawan and IPPB Workshop by Shri T.N. Rahate, General Secretary, NUPE, Postmen and MTS alongwith Secretary General FNPO and Representatives of FNPO at Delhi from 6-3-2018 to 9-3-2018.

On 6-3-2018 myself alongwith Shri R.H. Gupta, Asstt. Secretary General, FNPO and Shri Santosh Kadam, Asstt. Circle Secretary, NAPE C, Maharashtra Circle visited Dak Bhawan, met Shri Salim Haque Sir, Member (T), Ms. Usha Chandrashekhar Madam, Member (O), DDG of various section discussed following issues in detail -

Member (O): Improvement in delivery (Nodal) for separate parcel system in Maharashtra and other Circle and requested to issue guidelines for delivery of all types of parcel through Delivery Post Office only. Member assured to visit Maharashtra circle this month and meet Union Representatives alongwith concerned officers of Maharashtra Circle and settle the issue.

Member (T): Difficulties faced by staff after CSI rollout and issues related to finacle after CSI - Officer assured to look into the matter and resolve issue as early as possible. DDG (P), DDG (Estate), and other DDGs and Directors:

- (i) Absorption of surplus GDS candidates who are declared successful in GDS to Postmen Exam 2017 on vacant post of Postmen in Mumbai Region from Navi Mumbai Region and other Regions of Maharashtra Circle.
- (ii) Accommodation at Kolhapur Head Office for PSK and IPPB Offices, we requested to acquire accommodation given to CTO and not to disturb counter/delivery areas in main building.
- (iii) Modification of Divide Beat/Holiday Duty Fixed Monetary Allowance multiplication after implementation of 7th CPC.
- (iv) Increase in rates of Dress Allowance upto Rs. 10,000/- yearly.
- (v) Modifications in recruitment Rules of Postmen, MTS, PA/SA cadres. New recruitment rules will be framed in this month and Orders will be issued shortly.

We also demanded to ask BSNL to surrender the accommodation given to them for CTO Offices.

- 2. We demanded 100% recruitment of GDS and Postman & MTS vacant post.
- 3. We asked software related questions and it is known that same **finacle software** will be used for IPPB.
- 4. Basic idea behind IPPB is to providing **doorstep banking** services to the rural customer who is not having smart phones or internet access.
- 5. For Urban customers its new e-wallet introduced to buy Department of Post the most reliable banking services in India.
- 6. New technology like **QR Debit Card** will be introduced by IPPB.
- 7. We hope it will open new doors for India Post and our future will be bright so FNPO will support IPPB initiative with the condition of non-privatization and 100% stake of India Post in IPPB.

Respected Sir,

In connection of the above cited subject, it is to state that my **Federation is against** to utilise the services of **OPA in delivery** of all kinds of Articles in the Department of Posts which is having **manyfold reasons**.

Sir, there are some important points in this respect which either is **not discussed** or being brought to your kind Honour or **not briefed in detail.** Hence the continuance of the **OPA Scheme is the last option** seen by such officers. The gain or lost of the Department is not option before the Department, but the survival with **present Private Competition** on one hand and retain the belief of the customer on other hand has to be **given priority.** While **giving permission to the OPA this issue is neglected** by the concerned. Hence it is requested **to stop implementing the said OPA with immediate effect.**

Sir, following points are worth to consider to stop delivery through the OPA.

- (i) In the **Departmental/Council** it was assured that the **IPPB** would be the corporate one. No other part of the Department will be **outsourced** is the Decision/Agreement reached in the Departmental Council.
- (ii) The Departmental Staff is trying to maintain 100% delivery aim in this shortage of staff.
- (iii) The shortage of Postman/MTS Staff is nearby 50% in all the Circles that cause limitations to the staff. The recruitment of vacancy from **year 2009** to 2018 must be filled in at the earliest.

- (iv) The Department of Posts observed how the **Outsourced Postal Examination** create havoc. The **image of Department** is lost in this case on one side and **incurred heavy expenditure due to private company.** Secondly, the **Court cases arises due to the said private Company.**
- (v) The customer is fed up from the **private courier services** and attracted to our Department due to prompt and timely service. If the private person enters in it they may not be given such service as the Departmental official in shape of the responsibility, reliability.
- (vi) The other services like **pick-up** and delivery from the other staff of the Department may be utilised whenever required at requisite points. But the private services should anyhow be avoided in the Department of Posts.
- (vii) Nowadays the nature of human being is changing. One wants to get more in short time of spell and less work. The couriers are the example of this and further cause **many frauds.** What action we can initiate against **OPA in any huge fraud.** Our Department would be ashamed of his doing at that time.
- (viii) The one of the incidence occurred that the **OPA service Articles** were **dropped** in letter box. Thus some of the **miscreants doing the business** and **some of the officers** are not giving factual information to the Department, **reason not known.**
- (ix) My Federation is **not against the engagement of the OPA in toto.** But their services may be utilised wherever there is limited scope for **fraud or damage** to Government/Department image by the **act** of such OPA.
- (x) Saving Bank has kept many agents for the work of State Government's Small Saving Scheme. These agents are **committing fraud in crores** and our employees are being put in jail. The Department is also recovering **lakhs of money** from the **employees**, and the **image of Department is also tarnished**. Therefore OPA system should not be implemented for **delivery of SPL RL Parcel and others (all accountable articles)**.

Sir, my Federation therefore request to consider all the facts narrated above and stop the OPA system in the delivery of all kinds of articles in the Department of Posts. A line of action is earnestly solicited from your kind end.
