## Shri T.N. Rahate, G.S., NUPE, MTS Group C and President FNPO visited Postal Directorate, Dak Bhawan, New Delhi

## Shri T.N. Rahate, General Secretary, National Union of Postmen, MTS Group C and President FNPO visited Postal Directorate, Dak Bhawan, New Delhi and met with DDG (P), DDG (SR & Legal), DDG (Estate), DDG (Estt.), Department of Posts and other Officers.

We met with DDG (P), DDG (SR & Legal), DDG Estate, DDG (Estt.) and other DDG, Department of Posts, Directors and discussed various issues of Postman, MTS Staff.

# **1.** Discussed recruitment on all vacant posts of Postman, MTS for the year 2009 to 2017 at all Postal Circles.

Model Rules for recruitment of Postman, MTS are under preparation and in near future will be sent through email; and published and will be kept on **India Post Website** for **one month for making suggestions** on these Model Rule and upto **March 2018** Rules for Recruitment will be amended.

Recruitment after March 2018 will be made according to new Rules.

We are trying that in amended Rules 100% Postman Recruitment should be from MTS and GDS only; (25% from Seniority-cum-Fitness from GDS and 75% from MTS and GDS Examination).

For MTS Recruitment 100% from GDS; (25% on Seniority-cum-Fitness and 50% through Examination. 25% from Casual Labour; if Casual Labour are not available those post will be **filled from GDS**).

#### 2. Department Council Meeting

We are trying for holding Departmental Council Meeting upto December last and hope it will be held.

#### 3. Fixed Monetary Allowance

7th CPC recommended Fixed Monthly Allowance for postmen beat full and divided Beat as per incorrect information provided by the Postal Department i.e. Rs. 48/24 instead of Rs. 98/50.

We have already taken the issue; now the Department will take matter with DOPT for making necessary changes to increase the Fixed Monetary Allowance.

#### 4. Regarding New Design of Uniform and Dress Allowance.

Discussed and it was told that new design of Uniform is approved and Minister wants to inaugurate this design. Uniform likely in the month of January 2018.

Rs. 5000/- per year for one Dress Allowance will be paid. We have **demanded Rs. 10,000/-** and our demand has been recommended and sent to DOPT till than **Rs. 5000/-** will be paid.

#### 5. MACP related Order dated 4-11-2013 ignoring TBOP/BCR for Postman, MTS.

The matter is still pending and nowhere it is implemented. The DDG (P) agreed to examine the case and the necessary Orders for implementation of MACP ignoring TBOP/BCR will be issued early.

#### **6. Union Representatives** should be guided how to **keep the relations with the Subordinate Staff and Union Representatives** to newly Recruited **IPS Officers under Training**

Discussed with DDG (P) regarding Training Subjects of IPS Officers that they should be guided how to **keep the relatiosn with the Subordinate Staff and Union Representatives** at all level for cordial relations in the larger interest of Staff and Administration. DDG (P) appreciated our suggestion and assured for doing the needful.

1. **पोस्टमैन रिक्रूमेंट :** पोस्टमैन और MTS के नये रिक्रूमेंट रूल में बदलाव होने जा रहा है। मॉडेल रूल सप्ताह India Post वैबसाईट में डाला जायेगा, और ई-मेल द्वारा भी भेजा जायेगा। उन पर आपके सुझाव आमंत्रित हैं। एक महीना वेब-साईठ पर रहेगा, आनेवाले सुझावों को लेकर रूल में बदलाव लाकर रूल बनाया जायेगा। 2018 से नये रूल लागू करेंगे। (उसमें 100% पोस्टमैन और एम.टी.एस. की रिक्त पोस्ट MTS, GDS and Casual Labour से ही भरी जायेंगी और पोस्टमैन में सिनियरिटी से GDS की सर्विस 10 साल के बाद सर्विस को लिया जायेगा ऐसा बदलाव आयेगा।

In connection of the above cited subject kindly refer the **High Court**, Aurangabad Bench, Maharashtra Judgement on above **five W/P**. The Honourable High Court Bench, Aurangabad given in favour of the applicants. Further it is Ordered to give 50% of the back wages to the said applicants.

Sir, while doing correspondence and **discussion on the subject and Circle Office** level, the assurance was given to take action accordingly **within 45 days** from CO level. But after 45 days period is over the **review petition is submitted by the CO.** 

As per my knowledge, there is no any constructive **points against the judgement only some names are added.** It is nothing but to pass the time and to mislead the case from the main issue. As such the **result would be against the Department and unnecessary expenditure of the Department with loss of money** and valuable hours of the many officers who are paid for.

In the Marathi, English Newspaper and News Channels are also showing the same things the Maharashtra Circle Administration is not fully knowledgable on the said issue. By doing this the Circle Administration is trying to show their own wrong deeds and thus further discouraging the image of the Department in the eyes of the common man and also to the Judges of the High Court.

Sir, it is the fact that the Manipal Company conducted the examination. The Department lodged FIR against the said Company. But there were our officers like ASPOs/SSPOs/SPOs were called for to check the result which was prepared by Manipal Company. The Circle Office has taken 6 months to check this result and then issued call letters to the candidates whose addresses were of UP, Bihar, Rajasthan and Haryana. The fact should be known to the Circle Office while issuing call letters to above State candidates address.

It means whether the officers of the Maharashtra Circle may also managed by the culprit candidates of the said States. Hence, in said FIR the names of the Circle Office Officers who were involved in the said case must be included. But same were not included best known to the concerned.

Sir, as per my knowledge in this review petition as there is **no any strong point this case** also will be **rejected by the Hon. Court**, as per all other cases were lost by the Department. It is the fact that there are no any **perfect knowledgeable officer posted for Court matter and Recruitment and other responsible branches.** All such officers are doing their duties to **fill the GAP only. They do not have perfect knowledge** of the branch. As many of them are working at same Mumbai GPO Old Bldg. premises **for years together**.

Sir, no doubt the Manipal Company conducted the examination. But the invigilators were our ASPOs/SPOs/SSPOs Cadre officers who may not have properly checked the photos, signatures or not taken any action against such culprit candidates during the course in the examination Hall or during document verification period, before declaration of result and sending the call letters. The result were declared and 356 candidates worked for 8 months. There were no objection while declaring the result

or joining them for 8 months service in the Department. Now said officers are giving wrong information to the media and thus the image of the Department is going to be down. It is very clear that what these officials have done in 2 years. They caused the candidates go to the Court of Law for the justice.

Sir, due to result and further joining their duties for 8 months and further consequently and to their services the candidates must go to the Court of Law for justice. Having wrong procedure adopted by the officers of Maharashtra Circle they lost the case at Aurangabad High Court Branch as usual. But further they would not won the case in Supreme Court also, because the Judgement of the Aurangabad High Court Bench is based on the verdict of Supreme Court only. Whatever expenditure incurred for the said case is due to negligency of and not having thorough knowledge of the subject to the officers of the Maharashtra Circle Administration. The Aurangabad Bench Ordered to effect 50% wages of back period. Now the Maharashtra Circle Administration is lingering the issue and thus caused to increase the 50% back period of wages of those 356 candidates. It is thus the question whether the Department will draw the said amount from the Department or from the pockets of the purposely erring officers of the Maharashtra Circle.

- (A) Sir, in this juncture my Union request your kind Honour to direct the concerned to Order all the candidates to rejoin their duties immediately, who have not joined yet they also should be Ordered to join at the earliest as per the Order of the Aurangabad High Court Bench. Whoever would be not entitled for Departmental Job in the Vigilance Inquiry be initiated Disciplinary Inquiry.
- (B) Taking into consideration of FIR lodged against Manipal Company the Vigilant Inquiry of Officers of Circle Office Mumbai would be initiated at the higher level and those who are seen responsible for those irregularities or wrongdoings those names should be included in said FIR. Because for 6 months the Circle Office kept the papers with themselves and after Rechecking Verification was done by ASPOs, SPOs and SSPOs results were announced. Therefore concerned officials are also responsible, so all the officials name should be included in the FIR and then inquiry should be conducted.

**Vigilance action** is taken against the said official, even he is not transferred to other Division also. There may be **one lobby** of the Officers in existence who are protecting each other if anything goes wrong against them. The Head of Circle may be unaware of the tactics of these officers. But all this is due to their **longest stay at the same building or region** itself. And many other cases are also pending at CO/VO. Till date enquiry is not conducted properly nor any proper action has been taken.

Sir, Maharashtra Postman and MTS employees are mentally and physically stressed and falling ill **due to 50% shortage of employees** and Department keeps on introducing new schemes like Amazon and other Parcel Delivery, **Separate Parcel Delivery**, Speed Post and Register Letters, **100% delivery** for parcels to be sent; all these schemes are creating pressure on the employees and many are taking voluntary retirement. The concerned officials of CO are least bothered about the condition of the employees. They are unable to understand their own responsibility and just passing time irresponsibly. Due to this irresponsibility, the Postman MTS staff are suffering from various illness and slowly dying. The Union is therefore losing its **tolerance power**.

Sir, you are therefore kindly requested to direct the **concerned to take suitable** action in this case without loss of further time and **incurring heavy loss of the** expenditure due to this case.

A line of early action in this case is earnestly solicited at your kind end and a line is reply is kindly requested.
