**Remove Typing and Computer Test
from Syllabus in LGO Examination**

Sub : Modification of exam syllabus in LGO Examination - regarding.

The All India Postal Employees Union Postman and MTS and National Union of Postmen and MTS Gr C in continuation of our earlier joint notification to the Department on 16th November 2018 about our intent to go on agitation on our sectional Charter of Demands wishes to raise our objection once again on the unilateral notification of syllabus for LGO Examination that includes a paper on 'Computer Skill Test' and to seek modification as follows.

The inclusion of 'Typing and Computer' as an exam paper is most unjustified. Even when the Department chose to introduce computerization for its operation, it had the patience to allow a time gap for the existing Postal Group 'C' staff to learn the knowledge to work i computers. Repeated coaching classes were organized by the Postal Training Colleges and the Department for the staff to master the operations through computers. In fact ours is the only Department that did not go for any outside expertise but relied on our own Group 'C' staff to become 'System Administrators' to look after the work of computerization in all Post Offices throughout the Country and also to guide the staff step by step through the art of working in computers.


The introduction of the syllabus for the LGO Examination with a separate paper on 'Typing and Computers' (CST) is most unjustified. The existing Postman and

MTS are to be trained by the Department in computer skill but marking a separate exam paper on the subject is not acceptable. The training can be imparted during the long induction training as PA/SA, which is natural and non-objectionable. The premature introduction of a separate exam on the topic will only result in failure of majority of LGO candidates in the paper that will open the doors for major out-door recruitment from the open-market. This will reduce the percentage of LGO officials getting promoted as PA/SA, which cannot be the intent of the Department, as the Postman are relied upon for a variety of postal operations to increase the reach with the members of public.

Under the circumstances, both the All India Union once again seeks your personal intervention to cause to modify the exam syllabus so that the separate paper on 'Typing and Computers' is removed but necessary training is imparted during the induction training for the successful LGO candidates to make them fit enough before entering the actual field work as PA/SA. The hasty action the Department will only cater to the increased discontentment among the LGO staff resulting in avoidable consistent agitations and Programme of Action leading to dislocation of peaceful work.

I feel it very painful to invite your kind attention to the large no. of vacant Posts in all the cadres in Dept. of Posts and especially the vacancies in Sports Quota not filled in by many circles over last four years raising some queries on these vacancies. Many circles are not clear about the category of sport for which the sports quota to be filled. However, we wish to bring to your kind honour's notice that, other Central Govt. Departments are not facing any difficulties in recruitment of sports quota and they regularly undertake recruitments in this quota. Moreover, the candidates recruited through sports quota by other departments like Army, Railway, Income Tax etc. are showing their talents at national sports competitions. In fact, achievement by employees in sports quota at national level is away of publicity of the department, especially the achievements in team games like Cricket, Football, Kabbaddi etc. However, in DOP the annual sports competitions within the department are conducted as a formality only.

In this regard, we request your kind honour to issue clear orders for recruitment of sports quota immediately. Further, we request that, there are many sports persons in GDS Cadre also and they also should be considered for sport quota vacancies in DOP. Also some provision is requested to be made for engagement of sports persons in GDS cadre.

A line of reply with positive action is highly appreciable.

Office Memorandum

Subject : Central Civil Services (Revised Pay) Rules, 2016 - opportunity for revision of option to come over to revised pay structure.

The undersigned is directed to invite attention to Rules 5 & 6 of the CCS (RP) Rules, 2016 regarding exercise of option to come over to the revised pay structure effective from 1.1.2016 as notified by the CCS (RP) Rules, 2016 and to say that the said option was to be exercised within 3 months of the date of notification, i.e., 25.7.2016 of the said Rules. The Rule 6(4) thereof provides that the option once exercised shall be final.

2. The Staff Side of the National Council (JCM) has requested that employees may be given another opportunity to re-exercise their option in view of certain hardships caused to certain employees. A number of references have also been received in this Ministry, proposing that the affected employees may be given an opportunity to re-exercise their option.

3. The matter has been considered and the President is pleased to decide that in relaxation of the stipulation contained in Rule 6(4) of CCS (RP) Rules, 2016, the Central Government Employees, who have already exercised their option to come over to the revised pay structure as notified by the CCS (RP) Rules, 2016, shall be permitted another opportunity to revise their initial option in terms of Rules 5 & 6 thereof. The revised option shall be exercised within a period of 3 months from the date of issue of these Orders. The option once exercised in terms of these orders shall be final and shall not be liable to any further change under any circumstances. All other terms and conditions as laid down in the said Rules 5 and 6 shall continue to be applicable.

4. It is obvious that in respect of those employees who have already exercised option to come over to the revised pay structure from 01.01.2016 itself or in whose case the revised pay structure took effect from 01.01.2016 and who re-exercise their option under these orders to come over to the revised pay structure from a date subsequent to 01.01.2016 as per Rule 5 of CCS (RP) Rules, 2016, the arrears on account of revised pay already drawn by them from 01.01.2016 up to the date from which they now opt to come over to the revised pay structure shall be recovered.

5. In their application to the employees serving in IA&AD, these orders were issued after consultation with the Comptroller and Auditor General of India.
