Employees are deceived

This was not at all expected from the Government, who came in power by giving various assurances including justice for all and a great injustice made towards CGES, by issuing anti-employees Orders on allowances.

We all know better that after the acceptance of 7th CPC Report by the Government, which was not justified. The CGE confirmation has served the notice of Indefinite Strike with demand for modification in recommendation made by 7th CPC.

Being the Railway was also served Strike notice with all other CGE Unions; first time after 1961 Strike of CGE alongwith Railway. The Strike propoganda was on high speed and all CGE were stand as a rock to success the Indefinite Strike. Government after taking the atmosphere into consideration played the game and formed 3 Minister Committee to negotiate with Union to avoid Strike. Those three Ministers Committee consisting Shri Rajnath Singh Home Minister, Shri Arun Jaitley Finance Minister and Shri Suresh Prabhu, Railway Minister met with CGE Confederation and requested to withdraw the Strike notice. After prolong discussion the Committee proposed to form a Committee to look after the demands of CGE i.e. increase of minimum scale from Rs. 18,000/- to Rs. 26,000/-, enhancement of HRA and other allowances, scrapping of NPS, Change in fitment formula etc.

Committees were formed and discussion were held with Unions on various dates. Union/Federations put forth demands in detail, taking ample time now the Committee made report to the Government and Orders are issued. But main demand of incresae in minimum scale, scraping of NPS, change in fitment formula has not been considered and simply the Orders of HRA, TA, CEA etc. are issued.

But the date of effect is given as 1st July 2017 instead of 1-1-2016. Why this discrimination. The arrears amount of increased allowances of 18 months has been snatched in lawfully from CGE; which we should not allow. The CGE Unions/Railway Federations must think it over to launch nationwide protest agitation against this anti-worker move of Government. - T.N. Rahate

Subject : Enhancing Financial powers of the Chief Postmaster General and Postmaster General while conducting FRSC for Rented Buildings/Premises for Post Offices.

Respected Sir,

It is observed by the Union that while taking possession of the private buildings/premises for Post Office requirements the **PMG/CPMG** are having financial power of below Rs. One lakh. All cases above Rs. One lakhs are to be submitted to the Directorate for the approval. The **landlords are not waiting for long time that while the proposal is submitted** to the Directorate take some more time for approval. At this stage the **landlord are not favouring the Department.**

Sir, in cases of **old private rented postal building/premises** they are also not in good and sound condition. They all require the **repairs at rented buildings and other things.** In this case also the **PMG/CPMG** are not having sufficient financial power to carry out the required repair works. Some Post Offices are in the dilapidated condition like **Bhayandar** (E) & (W), Virar (West), Mulund East PO, many thousand other offices are also in danger

condition to live in. The postal staff is working continuously in such a bad atmosphere and pitiable condition nowadays also. In some places, there is **not sufficient place for working of the Post Office** and the seating arrangement for the staff.

According to the **landlord the rent** is not adequate as per the present time. Our Department is not in **position to increase the rent without the FRAC.** This cause many landlord to vacate the rented buildings through the Court Cases.

Sir, in this juncture **Union demand** that taking into consideration today **cost of dearness index the FRAC power** may be allotted to the PMG/CPMG concerned. Their financial powers may be enhanced taking into consideration of present cost index. If **DPS and PMG** is allotted upto Rs. 3/- lakhs and CPMG upto Rs. 5/- lakhs there may be some relief. This may cause many problems to be **sorted out at local level.**

Sir, in case of **old rented buildings**, instead of **taking FRAC** time to time the rent may be increased during one or two years **as per the local Government rate automatically**. If such provision is made in the Rule it would be beneficial to the Department. I hope the above said suggestions would be considered and action would be taken accordingly. A line of action on the above subject is highly solicited.

OFFICE MEMORANDUM

Subject : Remuneration to be paid to the Gramin Dak Sevaks engaged as substitutes in short term vacancies of Postmen/Mail Guards and MTS.

Consequent upon the implementation of the Seventh Pay Commission's recommendations, the matter regarding the rates of remuneration payable to Gramin Dak Sevaks engaged as substitutes in short term departmental vacancies of Postmen/Mail Guards and MTS has been reviewed.

2. It has now been decided that the remuneration of the Gramin Dak Sevaks engaged as substitutes in short term departmental vacancies of Postmen, Mail Guards and MTS may be calculated on the basis of the minimum pay of the respective levels of the pay matrix in which the substitute is engaged as defined in the CCS (Revised Pay) Rules 2016 and as mentioned in Table below:

3. In future, GDS who are willing to work as substitute will be paid at the minimum pay of the respective Levels of the Pay Matrix barring other allowances like HRA, Transport Allowance etc. with effect from 01.01.2016.
